


Family Inclusion

The following members may be included in an application for citizenship by investment.

- ✓ Spouse
- Children of the main applicant or of the spouse, if:
 - Aged under 18
 - Aged 18 to 30 and in a dependency relationship with the parents
 - Aged 18 or over and physically or mentally challenged, and substantially supported by the main applicant or his or spouse
- ✓ Parents of grandparents of the main applicant or of the spouse who are substantially supported by the main applicant or his or her spouse
- ✓ Spouses of eligible parents or grandparents of the main applicant or of the spouse if substantially supported by the main applicant of the main applicant's spouse.
- ✓ Siblings of the main applicant or of the spouse aged 18-25, single, childless, and substantially supported by the main applicant of his or her spouse
- ✓ Siblings of the main applicant or of the spouse aged under 18, single, childless, substantially supported by the main applicant or his or her spouse, and in receipt of consent to make an application from all persons with parental responsibility

DOMINICA CITIZENSHIP INVESTMENT SUM AND PROCESSING FEES

Effective July 31, 2024, The Government of the Commonwealth of Dominica has revised the investment that is required for participating in the CBI program in return for Citizenship of the Commonwealth of Dominica. You can acquire citizenship through one of two methods; either you make a direct contribution to the country's Economic Development Fund [EDF] or into an approved Real Estate Project. The investment sum and application processing fees for each option are below.

Investments and Fees

1 EDF Option - Direct Monetary Investment

The following sums are payable by a participant under the Direct Monetary Investment Option (the "EDF Option "):

- √ Single Applicant US 200,000
- ✓ For any additional dependent under age 18 USD 25,000
- √ For any additional dependent age 18 and aboveUSD 40, 000

2 Real Estate Investment

The following are now payable by applicants participating in the CBI Program under the Real Estate Option:

4 Exception

If an application is submitted within ONE YEAR from the granting of citizenship to Original Main Applicant, the following sums shall be sufficient:

| √ | Investment Sum for Spouse | US\$50.000 |

| √ | Mandatory interview | USD 1,000 |
| √ | Certificate of Naturalisation Fee | USD 500 per dependant |

The entire family including all Dependents of the Main Applicant can be included in one application.

There is no numerical limit on the number of Dependents provided they are the following persons fully supported by the Main Applicant.
